**Proposed amendment to section 1107 of Article 1:**

**1107. License Fees.**

(a) Except as provided in subsection ~~(b)~~(c) herein, the fees for the issuance and biennial renewal of the following licensing categories shall be fixed as follows:

- (1) Importer's license ~~\$650~~750
- (2) Furniture and bedding manufacturer's license ~~\$650~~750
- (3) Wholesale furniture and bedding dealer's license ~~\$540~~625
- (4) Supply dealer's license ~~\$540~~625
- (5) Custom upholsterer's license ~~\$360~~420
- (6) Sanitizer's license ~~\$360~~420
- (7) Retail furniture dealer's license ~~\$420~~140
- (8) Retail bedding dealer's license ~~\$420~~140
- (9) Retail furniture and bedding dealer's license ~~\$240~~280

(b) Except as provided in subsection (c) herein, the fee for the issuance and annual renewal of the insulation manufacturing license shall be \$2,000.

~~(b)~~(c) The reduction or waiver of any license fee shall be made only in accordance with subsections (b) and (c) of Section 19170 of the Business and Professions Code.

~~(e)~~(d) The delinquency fee and additional penalty fees for subsection (a), herein, are those specified in Section 19170.5 of the Business and Professions Code.
